
original historical sources that can open windows onto the past by means of polling data.


**Question**: What do you think is the ideal number of children for a family to have?


Question: Do you think most people can be trusted?




**Question**: If there should be another world war, do you think the hydrogen bomb will be used against us?




Question: Which of the TV programs on this list have you, personally, seen in the past month?




Question: Do you think the day will ever come in the South when whites and negroes will be going to the same schools, eating in the same restaurants and generally sharing the same public accommoda-

### **Expanding Nation**


Question: It has been proposed that Hawaii and Alaska be made the 49th and 50th states in our union. Do you think they should become states or not?
