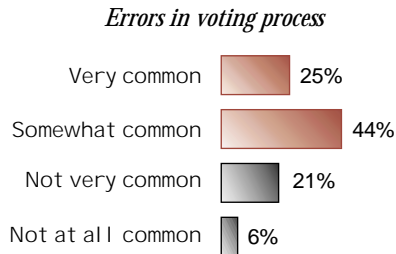
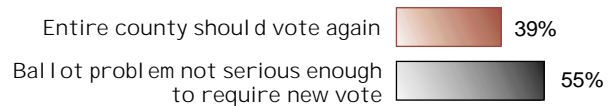


**Question:** Do you think errors in our voting process are very common, somewhat common, not very common or not at all common?



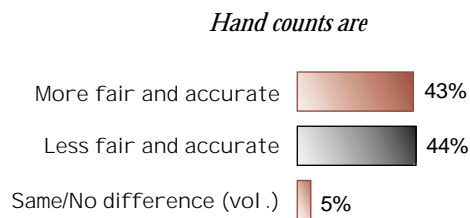

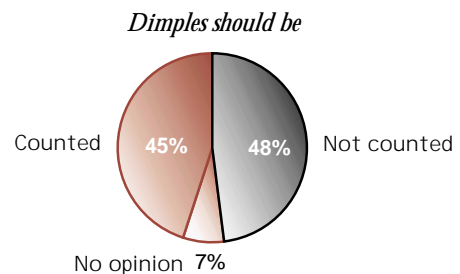

**Question:** In general, do you think counting punch-card votes in Florida by hand is more fair and accurate or less fair and accurate than counting punch-card votes by machine?



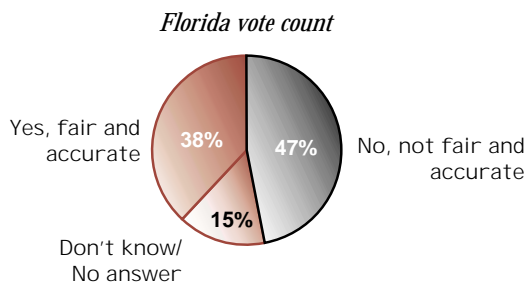

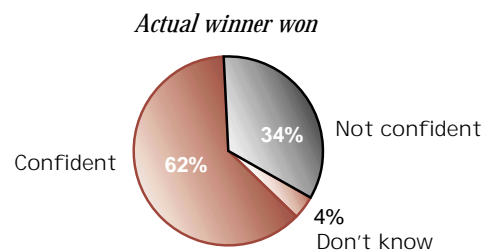

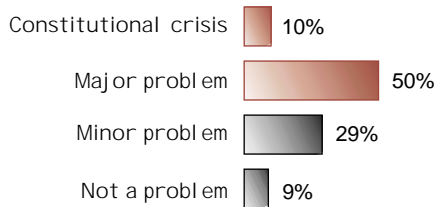
**Question:** How confident are you that in the end the presidential candidate who actually received the most votes in Florida will be declared the winner? Are you...?

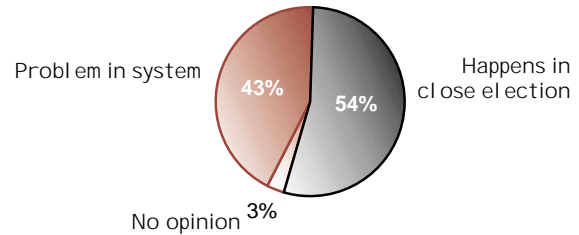
# Democratic Spirit Prevails

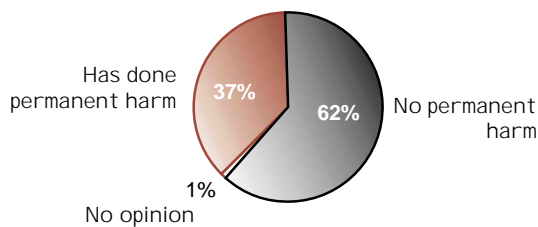

**Question:** Do you think this situation reveals serious problems in this country's system of electing the president, or do you think it's just the kind of thing that can happen in a very close election?



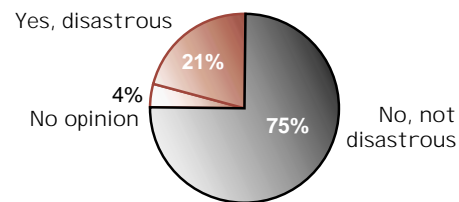

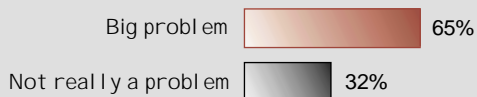
**Question:** Suppose for a moment that the candidate you did not support ends up becoming president. Do you think that he would be such a bad president that it would be disastrous for the country, or not?

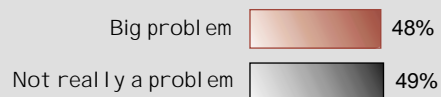
## Controversy, More than the Delay, Was the Problem
