

## Smoking: A Huge Decline in Rates



### For the First Time, the Rates for Women and Men Are Now the Same









Question: ... Do you think the Senate did the right thing in killing this tobacco bill, or do you think the Senate should have approved the tobacco bill?






Question: ... If your member of Congress opposed comprehensive tobacco legislation, would this make you more likely or less likely to vote for this person, or would it make little difference either way?










































Question: What is your opinion regarding smoking in public places?... Should they set -aside certain areas, should they totally ban smoking, or should there be no restrictions on smoking?


