


Do you currently own a cellular phone, or not?

How often do you use your cellular phone—every day, several times a week, about once a week, less frequently, or never?




How serious do you think are the health risks associated with cellular phone use—very serious, somewhat serious, not too serious, or not serious at all?


Do you consider... a cellular phone or car phone an essential part of your life, or not?


In general, do you favor or oppose the policies of some restaurants and other public establishments that forbid people to use cellular phones on their premises?



How often so you use a cellular phone while driving—every day, several times a week, about once a week, less frequently, or never?






How dangerous is it when drivers use a cellular phone while driving-very dangerous, somewhat dangerous, not too dangerous, or not dangerous at all?
