

Do you approve or disapprove of the way George W. Bush is handling his job as president?



PERCENT RESPONDING APPROVE





PERCENT RESPONDING VERY IMPORTANT







If the [2004 presidential] election were held today, would you definitely vote to re-elect George W. Bush for president, consider voting for someone else, or definitely vote for someone else?





PERCENT RESPONDING A LOT OF BLAME



To what extent do you think that the decrease in the government regulation of corporations is to blame for the recent scandals involving corporations—a great deal, a moderate amount, not much, or not at all?


Do you blame the Republicans or the Democrats more for the decrease in the government regulation of corporations?

Which political party, the Democrats or the Republicans, do you trust to do a better job handling the issue of financial fraud and accounting irregularities by large business corporations?



Question:




