PUBLIC OPINION ON THE FLAG


Editor's Note:

On June 21, the House of Representatives voted 254-177 in favor of a constitutional amendment permitting laws which prohibit the desecration of the US flag. This was 34 votes short of the two-thirds majority required (in each house) under Article V of the Constitution. Thus, the amendment is dead, at least for 1990.


What does the US public think about a flag-protection amendment? How strong is public sentiment? How likely is a vote cast in the House June 21 to influence votes cast in the country next November? The data on these two pages summarize what surveys tell us on these questions.


